- 5. Sanction of financial assistance for educational purpose:
- 5.1 Sri Bhavahara Rao informed that 10 applications for financial assistance for educational purpose (04 new applications and 06 old applications) and 01 application for medical assistance were received and placed the same along with the enclosures before the governing body meeting.

<u>Medical Assistance</u>: Mr Zafrullah Khan Md. working as Electrician, has applied for medical assistance for his son Md. Mohaboob Khan who got his leg (lost in an accident) operated by some charitable organisation and now wants to fix an artificial leg that costs Rs.14,000/-.

5. 3 These applications were duly scrutinized by the Governing Body members and it was unanimously resolved to sanction financial assistance, in accordance with our norms as these applications forms were submitted with necessary fees certificates from respective colleges/schools along with essential mark-sheets. Details of educational assistance sanctioned are as follows;

- 6. Any other matter with the permission of chair:
- 6.1 Inspection of Govt. Primary School under 'badi runam theerchukundam'
- 6.1.1 As was discussed in the July 17 General Body Meeting, Sri G.Bhavahara Rao has visited the said school with Sri Krishna Mohan, Ordinary Member along with a mason to take an estimate to repair the existing bathrooms there. To the visiting members' surprise, the Visakhapatnam Municipal Corporation has already started the repairing work and the visiting team of AASARA has returned from the school after enquiring about the ongoing repair work.
- 6.1.2 This was discussed at GB meeting and came to the conclusion that since the President, Vice President and one committee member are on tour to abroad, members have decided to defer discussion on the said issue till their return to India.
- 6.2 Extending additional financial assistance to Vijaya Sai Yoga Charitable Trust.
- 6.2.1 As dicussed in the GBM of July 2017, a team consists of Sri Raghava Rao, Sri T.Purushotham and Sri Prof A.S.Namboori had visited Vijaya Sai Yoga Charitable Trust, Nerellavalasa and observed the following.
- 6.2.2. This trust has newly constructed a floor with four new rooms each to stay 2 old age people with attached bathrooms.
- 6.2.3 The said trust is expecting Rs.5,000/- per one old person towards monthly contribution/help to accommodate them in the newly constructed block there.
- 6.2.4 This issue has been discussed threadbare in the meeting and sought suggestions from Sri B.V.R.Sarma, AASARAA ex-president and member who attended the GBM as a special invitee, over legal implications which might arise once AASARA takes over the newly constructed block in the Trust.
- 6.2.5 Sri Sarma has ascertained from the Society about the funding capacity and asked whether the society can afford to pay for 8 members at Rs. 5,000/- per member i.e., Rs. 40,000/- per month, besides meeting expenditure for education and health. The Secretary explained that at present Rs. 40,000/- cannot be spent as there is no sufficient revenue but can be spent if any donations are received from the members and he also stated that some of the members are ready to donate the amount. It was also further mentioned that in case of necessity we can stop payment of the amounts towards education and health and divert the said sum

towards old age home expenditure. Then Sri Sarma asked whether the said donations are continuous in nature for only as a stop gap manner. If there is a guarantee that the said donations are continuous in nature, there may not be any objection to think over the same, and if not, it may be difficult to maintain the 8 members in old age home at the cost of the society.

Sri Sarma suggested that, for the present, the amount of Rs. 9,000/- may be paid as at present and as and when the society feels that it can pay any further amounts, then the society can request the owner of the old age home to allot the required number of beds depending upon the funding capacity. So Sri Sarma suggested finalising what the amount that can be spent on this account and then request the owner to allot required number of beds and as and when the Society is in a position to meet the expenditure through their own sources, then, the Society can request the owner to allot more number of beds. However, the issue of stoppage of assistance to education and health has not been discussed, at length, at this juncture. If, the Owner is providing food, shelter, recreation along with medical facilities, and other infrastructure for the well-maintenance of the old age persons, there may not be any problem for the Society to pay the amounts to the old age home on the same terms and conditions and there may not be any necessity to enter into an agreement to this effect. He has also suggested on the issue of providing Society's name plate on the rooms where the old age persons, suggested by the society, are accommodated.

The members at Governing Body Meeting decided to negotiate with the old age home for reduction of the monthly payment per bed, from Rs. 5,000/-, so that AASARAA could support more old age people in future also.

6.2.6 (1) The governing body has taken a final decision of sponsoring the old age persons as mentioned para 6.2.5 above.

To meet again on this issue, all members of the Society are requested to donate funds every month to meet the expenditure, so that more old age persons could be accommodated at the said old age home.

7. As there were no other points for discussion, the meeting was closed with a vote of thanks to the Chair.
