- a. "provided further, the Membership of a person who ceased to be a Member on the ground at (vi) refers to cessation of membership for 6 months or more, shall be restored in case he/she makes an application for readmission undertaking to pay the Permanent/Life Membership fees as prescribed from time to time, waiving the arrears of Ordinary Membership fees dues in respect of him/her".
- G.1.2 "A Permanent Member, who joins the Society or an Ordinary Member who opts to become a Permanent Member on or after 1st May, 2019, shall pay an amount of Rs.50,000/- in lump sum or in consecutive monthly instalments of not more than 50 towards membership fees, which shall be paid by 25th of a month." (amendment to bye-law No. 5 (v).
