We supported the education of Ms. Sangeetha last academic year also.



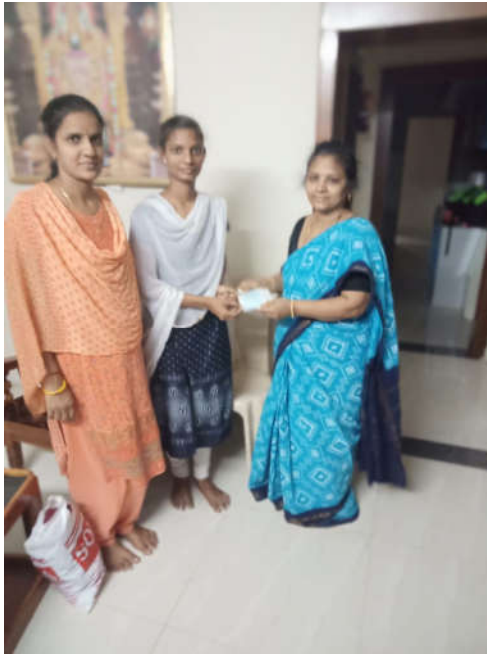
