**C. Full-fledged Life Member:**

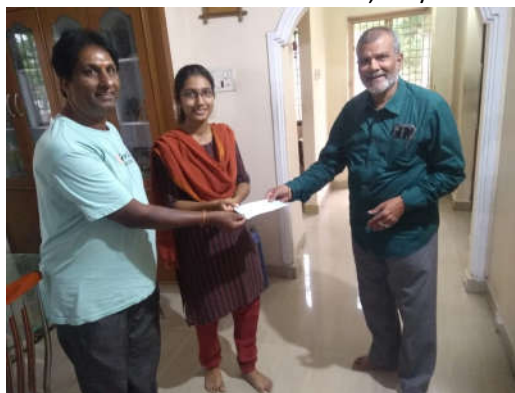
