Sri Rajulu is a labourer with an annual income of Rs.60,000/-.



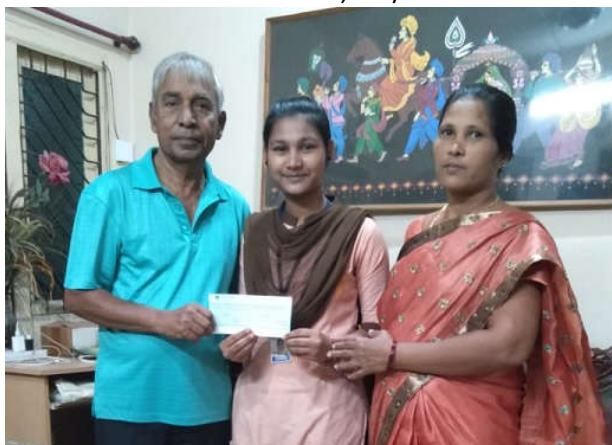
