



Monthly Activities – December 2020

A. Sad News:

I regret to report that Sri P. Rajeswara Rao, aged 85 years, a Permanent Member of the Society, who lived an active life, including serving as the All India General Secretary of Bharat Sevak Samaj, when Guljarilal Nanda ji was the Chairman, expired on 3-12-20.
