A. New Members

- b) issued an advertisement in the local edition of the "EENADU Classifieds" on 18-07-2021 and received only one concrete response and two enquiries.
- c) Sri P. Vinay Babu , Joint Secretary, visited the house on 9-7-21 and as the house owner was not willing to rent the ground floor, the proposal could not be considered.
- d) Vigorous search to find a suitable house is being made by Sri Vinay Babu, Sri Narayana Rao, Member and Sri Shaik Faried, our Well Wisher in Pendurti, China Mushirivada, Sujata Nagar and Sagarnagar areas.
- e) appealed to our Members to suggest any person known to them having empathy and who considers taking care of destitute senior citizens as a service and not vocation, on receiving an honorarium of Rs.10,000/- p.m., besides free lodging and boarding.
