



Monthly Activities – January 2022

A. Sad News:

I regret to inform that Ms.A. Savithamma garu, one of the inmates of our Vruddhaasrayam, expired 11-1-22 at about 1.15 a.m. while taking treatment at the King George Hospital (KGH), Visakhapatnam. She was 69 years old and is survived by two daughters and 3 grandchildren.

Ms. Nandini, her second daughter and Sri T. Maheswara Rao, son-in-law took Savithamma garu to their house on 27-12-21 and brought her back on the evening of 8-1-22.

She complained about loose motions on 9-1-22 and looked very tired and weak. A medical checkup was arranged, saline was given and prescribed medication was provided.

As her condition did not improve, with the courtesy extended by Dr. G. Sambasiva Rao, Principal, Andhra Medical College, whom Shri P. Vinay Babu, Joint Secretary, contacted, Savithamma garu was shifted, by 108 ambulance service, to the KGH in the night of 10-1-22. She expired at about 1.15 a.m. on 11-1-22 due to "Cardiogenic Shock" while taking treatment.

May her Soul rest in peace.

Sri P. Narayana Rao, Member, Governing Body and Sri N.K. Mohana Rao, Care Giver, made necessary arrangements for the treatment of Ms. Savithamma garu and her shifting to the KGH.

I may add that Sri P Vinay Babu and Sri M. Rama Rao, President were continuously monitoring the developments.

Shri Maheshwar Rao, son-in-law and Ms. Nandini, second daughter of Savithamma garu were at our Vruddhasrayam on 9-1-22 to take care of 'Savithamma garu and Ms. Jyothi, her first daughter joined them on 10-1-22. They also accompanied her in the ambulance to the KGH.

Rs. 5,000/- was given to Sri Maheswara Rao, who performed the funeral rites, to meet the expenses.
