Monthly Activities – July 2022

A. A Good Gesture

A.1 Mr. G. Arun Kumar, son of Ms. Lakshmi, studying Intermediate 1st Year at B.V.K. Junior College, Visakhapatnam-43, was sanctioned financial assistance of Rs.2,751/- for payment of tuition fee vide cheque No.144506 dated 16.2.2022 issued in favour of Bharateeya Vidya Kendram, Visakhpatnam, by taking into account the likely transfer of Rs.10,000/- to the bank account of the student's mother under "Ammavodi" scheme of the Government of Andhra Pradesh.

A.2 Ms. Lakshmi was good enough to return the amount of Rs.2,715/- on 14.07.2022 after credit of an amount of Rs.12,715/- under "Ammavodi" scheme by Government of Andhra Pradesh.

B. Financial Assistance to meet Medical Expenses:

B.1 Cheque no.144536 dt, 21.07.2022 for Rs. 50,000/- issued in favour of Machiraju Kidney Foundation, Visakhapatnam, towards the medical treatment of Master Tridev Manahira suffering from Thrombolic Microaniopathi (TMA) because of which the patient needs regular dialysis, was handed over to his mother Ms Bisakha Manahira by Sri T.Purushottam, Vice-President and myself at Seven Hills hospital, Visakhapatnam. Dr Gayatri, our well-wisher who is associated with the scrutiny of estimated expenditure for medical treatment was also present at the time of cheque presentation.

B.2 Sri Dibra Manahira, father of the patient is a poor former from Odhisha with an annual income of Rs.1,00,000/- and lives in Karuanjhar, Balangir, Odhisha.



C. Matters related to Vruddhasrayam:

- C.1 Visits to Vruddhasrayam:
- C.1.1 Sri T. Purushottam, Vice-President, AASARAA visited our Vruddhasrayam on 01-07-2022.
- C.1.2 Sri N.P.Ganapathi Rao, Member, Governing Body, Visakhapatnama visited our Vruddasrayam on 02.07.2022

Both of them spent some quality time with the inmates.

- C.2 Our Hon. Resident Manager and some of Our Office-bearers again rose to the occasion
- C.2.1 Sri P.Yoganand Rao, an inmate of our Vrudhashrayam was unconscious for a while after taking lunch at about 2 p.m on 15/07/2022. He regained consciousness within a few minutes with the care given by Sri N.Mohana Rao, our Honorary Resident Manager.
- C.2.2 It was decided by Sri M.Rama Rao, President, in consultation with Sri T.Purushotham, Vice-President, Sri P.Vinay Babu, Joint Secretary, Sri JLRK Varma, Member, Governing Body and myself to take medical help.
- C.2.3 Accordingly, Sri Purushotham dialled telephone no.108 and Sri Yoganand Rao was taken to the King George Hospital, Visakhapatnam. After thorough examination of Sri Yoganand Rao, doctors prescribed three medicines and said that all his vitals are okay and he did not require any admission.
- C.2.4 Therefore, he was brought back to the Vruddhasrayam. In the evening, Sri T.Purushottam and Sri P.Narayana Rao, Member, Governing Body visited the Vruddhasrayam and found Sri Yogananda Rao was doing well. Sri Premanand Rao, brother of Sri Yogananda Rao also visited him on 16.07.22.

Sri Yogananda Rao continues to do well.

- C.3. Purchase of a plot of land for construction of Vruddhasrayam:
- C 3.1 As per the decision taken in the Special Governing Body meeting held on 26.06.2022, S/Sri JLRK Varma and P.Vinay Babu has informed the land owner at Dibbameedapalem of the final offering rate of 2.25 lakh per cent and the land owner expressed his inability in offering the land at that price.
- C 3.2 After detailed discussion, it was unanimously resolved to offer additional Rs.10,000/- on the rate of Rs. 2.25 lakhs, that is Rs.2.35 lakhs per cent.
- C 3.3 It was further decided that Sri Vinay Babu and Sri J.L.R.K.Varma shall pursue the matter with the landlord and also obtaining 1B document
- C 3.4 Accordingly the matter was taken up with the land owner on 21.07.2022 by S/Sri Vinay Babu and Varma, who agreed to sell the land at the price of Rs 2.35 lakhs per cent and obtain 1B document within 3 weeks.
- C 3.5 After obtaining the 1 B document we shall get the opinion of Auditors and Lawyer and then convene an Emergency General Body Meeting.

D. Submission of Income Tax Returns:

- D.1 Our Auditors have successfully filed the Income-tax return of our Society for the assessment year 2021-22.
- D.2 I am glad to add that Rs. 31,360/ was credited to our account on 16.07.2022 towards refund of Income-tax by the department for the said assessment year.
