#### 4 Matters related Vruddhasrayam:

(a) The rent agreement with the landlord of the present premises of our Vruddhasrayam expired by the end of Sept, 22. We gave an oral commitment to the landlord to increase the rent to Rs. 20,000/- per month from the present Rs.17,000/- with effect from 01-11-2022.

Under the circumstances, the Governing Body at its meeting held on 11.09.2022 unanimously resolved to search for an alternative accommodation within city limits at a rent not exceeding Rs.17,000/- per month.

We came to know from Sri VVS Seshagiri Rao, our well-wisher and a cousin of Sri M Rama Rao, President, about a suitable independent house at # 8-85, HPCL Layout, Bakkannapalem, P. M. Palem, Visakhapatnam.

Sri KV Babjee and Sri G. Suryanarayana, Members, Governing Body, as requested by me, in consultation with the President, visited the said premises on 14-09-22 and found it suitable for our purpose.

I along with S/Sri Rama Rao, Babjee and Suryanarayana, contacted Sri VVD Prasada Rao, the House Owner on 21-09-22 and he was agreeable to let the house for our Vruddhasrayam at a monthly rent of Rs 12,000/-.

All our Members were requested to make it convenient to come to the above house at 4 p. m., on 5th October 2022 to see the same and decide about its suitability for our Vruddhasrayam and reasonableness of the rent.

We found the house suitable for Vruddhasrayam and the rent of Rs.12,000/- per month with an annual increase of 10% reasonable.

S/Sri Vinaya Babu, Joint Secretary, Sri D.Narasimha Raj, Treasurer and Sri JLRK Varma, Member, Governing Body who watched the video forwarded along with the WhatsApp message referred to earlier, were also of the same opinion.

Views of members were presented before the Governing Body held on 09.10.2022 and a formal decision was taken and communicated to all our members.

We have shifted our Vruddhasryam from old buildings to new premises at #8-85, Bakkannapalem, PM Palem Visakhapatnam on 29th October 2022 at 10.40 am.
