1. Sad news

1.1 Sri Margana Satyanarayana garu, Member, expired on 16-8-23 at 4.30 a.m. at Visakhapatnam.

Sri Satyanarayana, one of our oldest Members, was born on 15-4-1944, served in Visakhapatnam Port Trust for about three decades and retired as Traffic Inspector.

Sri Satynarayana garu left behind two sons and two daughters.
