1. Full-fledged Permanent Member

2. Matters related to Vruddasrayam:

2.1. Disbursement of old age pension to Sri P.Yogananda Rao

2.1.1 The monthly pension sanctioned to Sri P. Yogananda Rao by the State Government, was handed over to him on 1-6-23 by Ms.L. Aruna, Ward Volunteer, using the iris method.

2.2 Transfer of pension papers of Sri Yogananda Rao

2.2.1 The request for transfer of pension papers from Ravulapalem Sachivalayam-2 to Vivekananda Nagar-2 Sachivalayam, was successfully processed on 12-6-23 with the sustained efforts of Sri V.V.S.V. Seshagiri Rao, our Well Wisher, Visakhapatnam,

Sri G. Suryanarayana, Member, Governing Body, promptly responded to the request of Sri Seshagiri Rao and arranged to send the Aadhar card of Shri Yoganand Rao to the said Sachivalayam.

2.4 Registration of sale deed for purchase of agricultural land at Dibbameedipalem

2.4.1 The registration of the sale deed for the purchase of 22.5 cents of agricultural land at Dibbameedipalem at the Sub-Registrar's office at Anandapuram, Visakhapatnam District, was scheduled on 8-6-23 but due to a small glitch in the Form 1-B the same could not be done.

2.4.2 It was noticed that in the 1-B patta of the said land, it was shown that Sri Satyanarayana got possesion of the same by purchase and not by inheritance as was the case.

2.4.3 Sri Satyanarayana immediately applied for correction of the said entry through the Sachivalayam, which forwarded the same without delay to the Mandal Revenue Office. However, it was learnt that it may take about a week for the correction to be carried out by the MRO.
