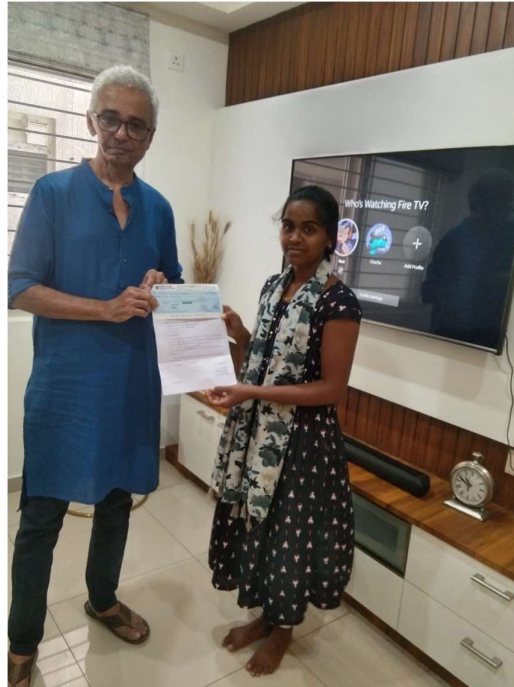
Ms. Mangamma works as a Maid servant and earns about Rs.96,000/- per annum.
